**COURSE DESCRIPTION:**

A political analysis of how selected works of literature from antiquity until very recently articulate visions of order and disorder.

Because this course is a mixture of lectures and a seminar, students need to be aware of some additional aspects of the course. These will also be discussed in the first class, January 11, 2022. First, for the seminar component, students are expected to participate in discussions and to be responsible for leading (or co-leading) one discussion each. We will formalize these assignments during the second class, January 13, 2022. To enable things to go smoothly two things are required prior to this class: (1) that everyone be sufficiently familiar with the assigned material that they can formulate their initial preferences for acting as seminar leader or co-leader, and (2) that they email me their preferences by January 9, 2022 so I can draw up a preliminary schedule before the first class and send it to everyone.

**COURSE OBJECTIVES & LEARNING OUTCOMES:**

Upon completion of the course, students will understand the place of literature in the human search for political, economic, social, and personal meaning. Works of literature are much broader in their significance than the conventional approaches to "arts and letters" tend to emphasize. In addition to being a great poet, for example, Shakespeare was also a great political philosopher. We will read several literary works, including plays, with an eye to examining their political significance rather than simply their literary merit. There is a fair amount of reading required, but most of the books and plays are reasonably short –no War and Peace. I will also make available on D2L suggested additional material that may be useful in the discussion components. Discussion leaders can make use of this material as they see fit.

**WRITING STATEMENT:**

Written assignments are often required in Political Science courses, including this one, and the quality of writing skills, including but not limited to such elements as grammar, punctuation, sentence structure, clarity, citation, and organization, will be taken into account in the determination of grades. Students are encouraged to make use of the services offered through Writing Support Services in the Student Success Centre (3<sup>rd</sup> floor of the Taylor Family Digital Library) or at <http://www.ucalgary.ca/ssc/writing-support>.

**ASSIGNMENT(S)/PAPERS**

Each student will be responsible for taking a leading part in one discussion. They can then submit a written report, based on the discussion and any other research, not to exceed 10-12 pages. The written work should be handed in within a week or two after of the oral discussion as an email attachment. The very last day to turn in your written reports is April 19, 2022. We will discuss this requirement in detail on January 13. Students will be expected to have looked over the material to be covered and to select one or two texts regarding which they would like to lead (or co-lead) the discussion.

**PARTICIPATION**

Students will be graded on their participation in discussions as well as on their success in leading the discussion for which they have responsibility. For every class, students are expected to have read and thought about the assigned readings and, if they are so inclined, to read critical analysis of the texts. Because 30% of your grade must be available to you the day prior to the withdrawal deadline (in this course, April 12, 2022), I will send you an email indicating the grade you have received for the participation component.

**MID-TERM EXAMINATION**

There is no mid-term examination.

**FINAL EXAMINATION**

The final exam is a take-home exam and will consist in an essay that gives students an opportunity to synthesize the material covered in the course. It will be available on April 12, 2022 and is due April 19, 2022.

**LATE PENALTIES**

Unless students have a rational explanation such as a medical problem or a genuine emergency, the late penalty for handing in the essay/research paper is 5% a week.

**INSTRUCTOR GUIDELINES**

Students requiring assistance are encouraged to speak to the instructor during class or after class. Email is also a common form of communication, but it is not always as effective a way of answering student questions as a conversation.

Students are welcome to use laptops and other electronic note-taking devices in this course.

**IMPORTANT POLICIES AND INFORMATION****Supporting Documentation and the Use of a Statutory Declaration**

As stated in the University Calendar:

Students may be asked to provide supporting documentation for an exemption/special request. This may include, but is not limited to, a prolonged absence from a course where participation is required, a missed course assessment, a deferred examination, or an appeal. Students are encouraged to submit documentation that will support their situation. Supporting documentation may be dependent on the reason noted in their personal statement/explanation provided to explain their situation. Students cannot be required to provide specific supporting documentation, such as a medical note.

Students can make a Statutory Declaration as their supporting documentation (available at [ucalgary.ca/registrar](http://ucalgary.ca/registrar)). This requires students to make a declaration in the presence of a Commissioner for Oaths. It demonstrates the importance of honest and accurate information provided and is a legally binding declaration. Several registered Commissioners for Oaths are available to students at no charge, on campus. **Absence From a Mid-term Examination**

Students who are absent from a scheduled term test or quiz for legitimate reasons are responsible for contacting the instructor via email within 48 hours of the missed test to discuss alternative arrangements. **Deferral of a Final Examination**

Deferral of a final examination can be granted for reasons of illness, domestic affliction, and unforeseen circumstances, as well as to those with three (3) final exams scheduled within a 24-hour period. Deferred final exams will not be granted to those who sit the exam, who have made travel arrangements that conflict with their exam, or who have misread the examination timetable. The decision to allow a deferred final exam rests not with the instructor but with Enrolment Services. Instructors should, however, be

### **Reappraisals**

The University Calendar states that for reappraisals of graded term work:

“A student who feels that a piece of graded term work (term paper, essay, test, etc.) has been unfairly graded, may have the work reappraised as follows. The student shall discuss the work with the instructor **within ten business days** of being notified about the mark or of the item's return to the class. If not satisfied, the student shall take the matter to the head of the department offering the course **within 2 business days of receiving the decision from the instructor**, who will arrange for a reappraisal of the work **within the next ten business days**. The University Calendar states that for reappraisal of academic assessments (final grades):

“A student may request a reappraisal of a final grade. The only element that will be considered is the final assessment(s) that makes up the final mark (e.g., final examination, final project, and final paper). The exception is when a grade for a piece of graded term work is made available to students after the last day of classes for the term in which the course is scheduled; that grade may also be considered in a reappraisal of the final grade.”

“A student seeking a reappraisal of a final grade should first attempt to review the final assessment with the department or faculty offering the course. After which the student shall obtain a Reappraisal of Final Grade form from [ucalgary.ca/registrar](http://ucalgary.ca/registrar) (under Student Forms). The student must indicate exactly what error was made in marking the final assessment and/or in computing the final grade.
