COURSE DESCRIPTION & OBJECTIVES

Federalism is a very dynamic process which continues to evolve. Since Confederation different issues, attitudes and challenges have shaped inter-governmental relations in Canada. The course will introduce students to the theoretical and empirical examination of federalism in Canada and other selected states. Topics to be dealt with include federal principles and organization, the division of powers, intergovernmental relations, fiscal federalism and the challenges faced in federal states.

By the end of the term students should have a thorough understanding of the principles underpinning federal systems and how they work in the real world. They will also appreciate the flexibility of such systems and understand why a federal form of government is the choice for so many countries. Students will also have knowledge of federalism as it plays out in some of these federal states.

Conducting a simple subject search using 'Federalism', 'Federal States', 'Canadian politics', 'Canadian Provinces', 'Canadian Constitution', 'Federal government Canada' or individual topics such as parliament, constitutions, and so forth should produce a list of resources for essay writing.

Written assignments are required in Political Science 426, and the quality of writing skills, including but not limited to such elements as grammar, punctuation, sentence structure, clarity, citation, and organization, will be considered in the determination of grades. RESEARCH PAPER

The paper should be 12-15 double-spaced pages including notes and bibliography, using the APA reference style (see https://ucalgary.ca/ssc/files/ssc/wss_apa_2014.pdf). The subject of the paper may be drawn from any of the themes covered in the course, but a proposal must be approved by the Instructor. A hard copy of the paper must be handed in.

Requests for extensions due to illness or similar reasons *must be made to the Instructor before the due date and must be supported by suitable documentation. Always keep an electronic backup copy of your paper to ensure against loss or other difficulties.*

Papers submitted late will be penalized by five percentage points (5%) per day (including weekends).

MID-TERM EXAMINATION

The Mid-term exam will be an in-class, closed-book exam in essay format. In addition to content, exams will be marked on the basis of grammatical clarity and coherence of arguments.

FINAL EXAMINATION

The Final will be a closed book, registrar scheduled exam. The exam will be based on material covered in class including readings, lectures, discussions, and presentations from the entire term. It will be in essay format and the duration will be 90 minutes.

INSTRUCTOR GUIDELINES

IMPORTANT POLICIES AND INFORMATION

Supporting Documentation and the Use of a Statutory Declaration

As stated in the University Calendar:

Students may be asked to provide supporting documentation for an exemption/special request. This may include, but is not limited to, a prolonged absence from a course where participation is required, a missed course assessment, a deferred examination, or an appeal. Students are encouraged to submit documentation that will support their situation. Supporting documentation may be dependent on the reason noted in their personal statement/explanation provided to explain their situation. This could be medical certificate/documentation, references, police reports, invitation letter, third party letter of support or a statutory declaration etc. The decision to provide supporting documentation that best suits the situation is at the discretion of the student. Students cannot be required to provide specific supporting documentation, such as a medical note.

Students can make a Statutory Declaration as their supporting documentation (available at ucalgary.ca/registrar). This requires students to make a declaration in the presence of a Commissioner for Oaths. It demonstrates the importance of honest and accurate information provided and is a legally binding declaration. Several registered Commissioners for Oaths are available to students at no charge, on campus. For a list of locations to access a Commissioners for Oaths, visit ucalgary.ca/registrar).

Falsification of any supporting documentation will be taken very seriously and may result in disciplinary action through the Academic Discipline regulations or the Student Non-Academic Misconduct policy.

Please note that while the form of supporting documentation provided is at the discretion of the student, the instructor has the discretion not to accept the supporting documentation if it does not corroborate the reason(s) given for the exemption/special request.

Absence From a Mid-term Examination

Students who are absent from a scheduled term test or quiz for legitimate reasons are responsible for contacting the instructor via email within 48 hours of the missed test to discuss alternative arrangements. A copy of this email may be requested as proof of the attempt to contact the instructor. Any student who fails to do so forfeits the right to a makeup test.

Deferral of a Final Examination

Deferral of a final examination can be granted for reasons of illness, domestic affliction, and unforeseen circumstances, as well as to those with three (3) final exams scheduled within a 24-hour period. Deferred final exams will not be granted to those who sit the exam, who have made travel arrangements that conflict with their exam, or who have misread the examination timetable. The decision to allow a deferred final exam rests not with the instructor but with Enrolment Services. Instructors should, however, be notified if you will be absent during the examination. Appeals

If a student has a concern about the course or a grade they have been assigned, they must first discuss their concerns with the instructor. It also means that grades cannot be distributed via email. Final exams are kept by instructors but can be viewed by contacting them or the main office in the Department of Political Science. Any uncollected assignments and tests meant to be returned will be destroyed after six months from the end of term; final examinations are destroyed after one year.
